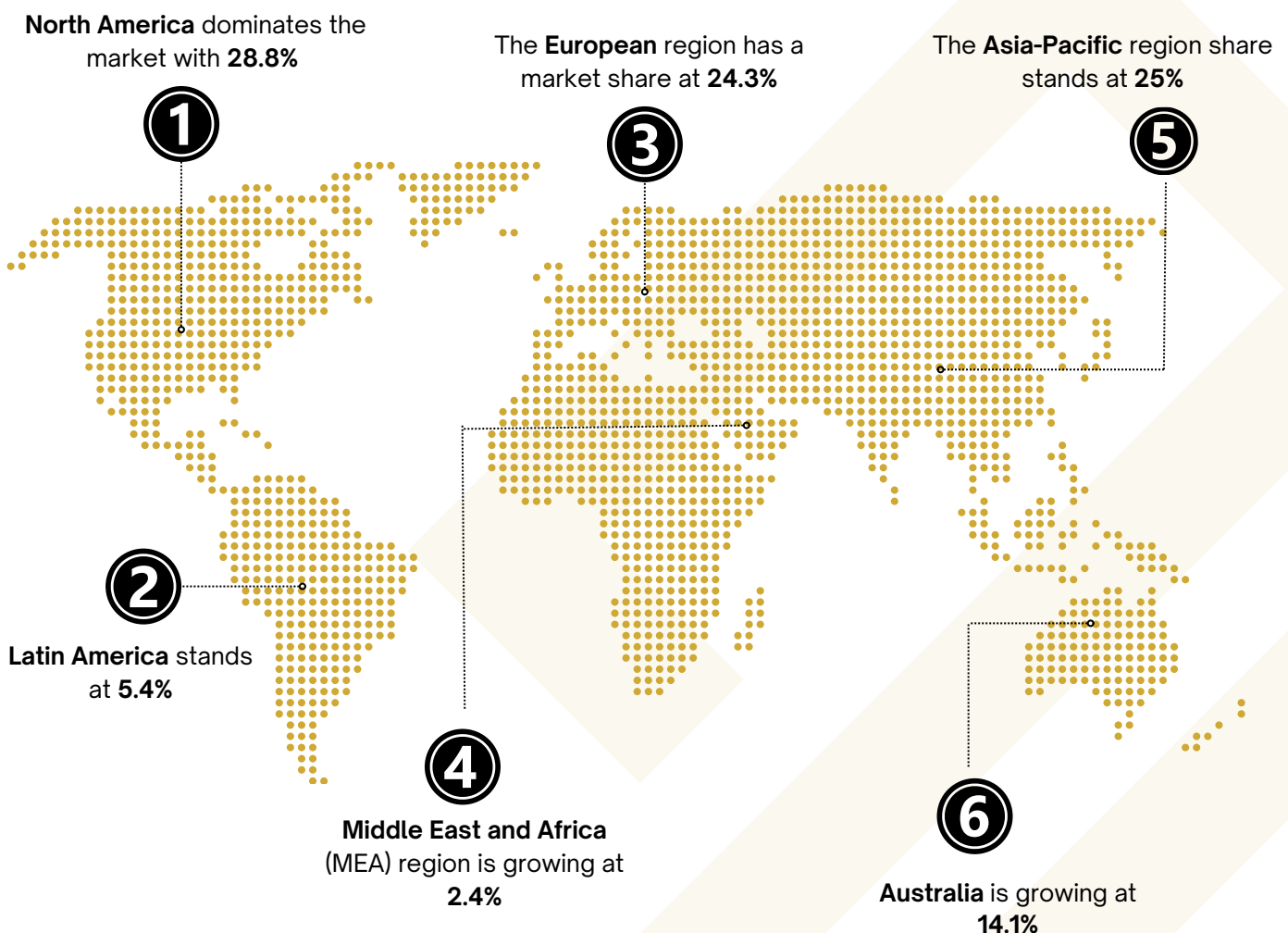


Figure 1: Market Share of AI Globally

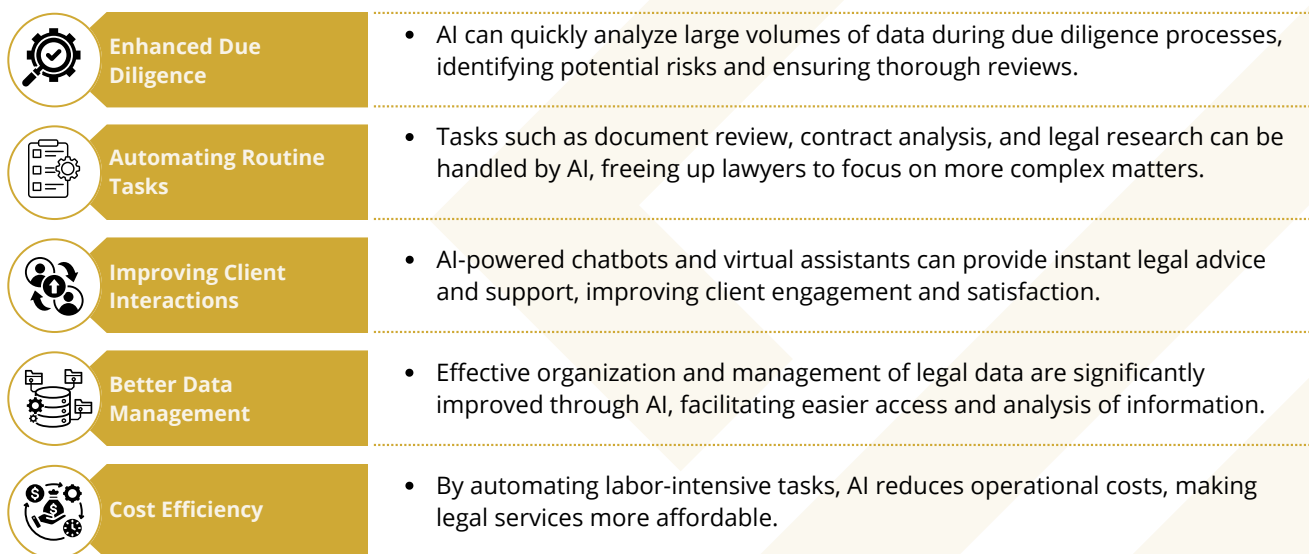


Figure 2: Exploring AI Transformation in Legal Businesses

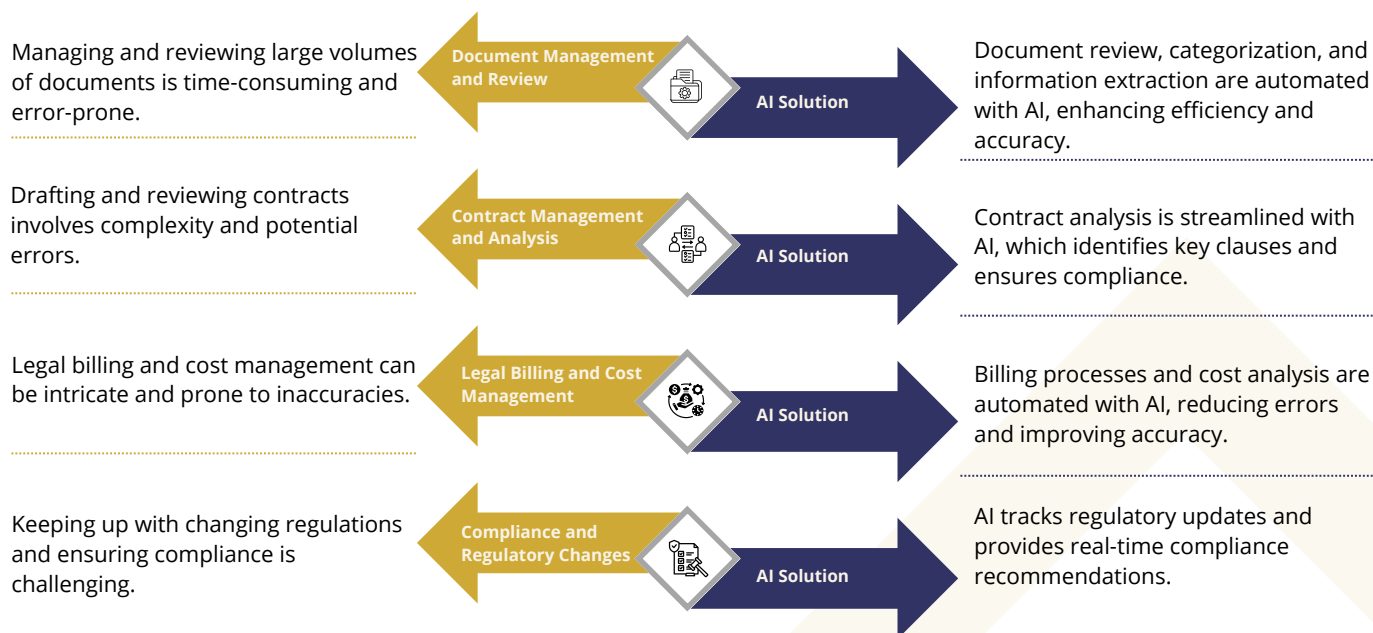


Figure 3: Addressing Current Legal Business Challenges Using AI

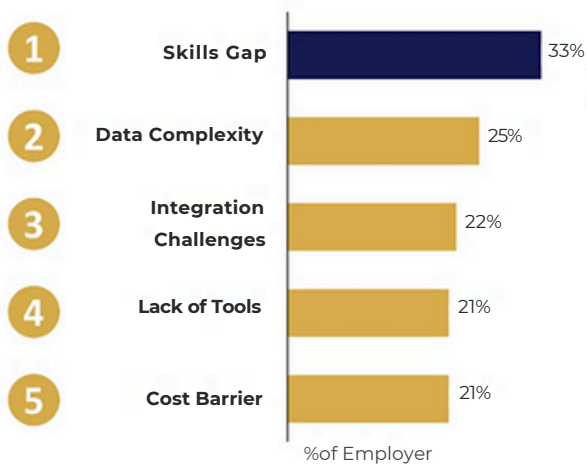

Share of employers saying lacking AI skills is a barrier to adopt AI (2023)

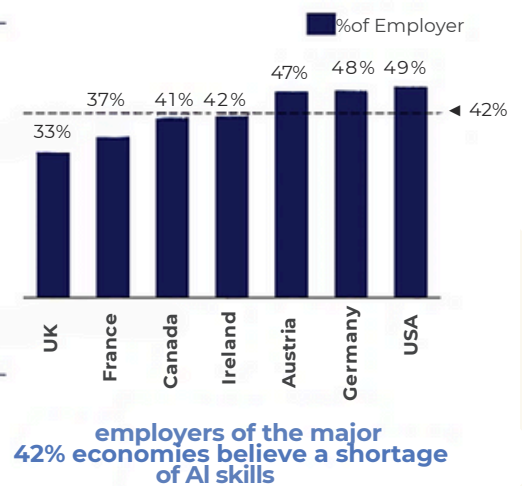


Figure 6: Factors determining the lack of adopting AI Technologies
