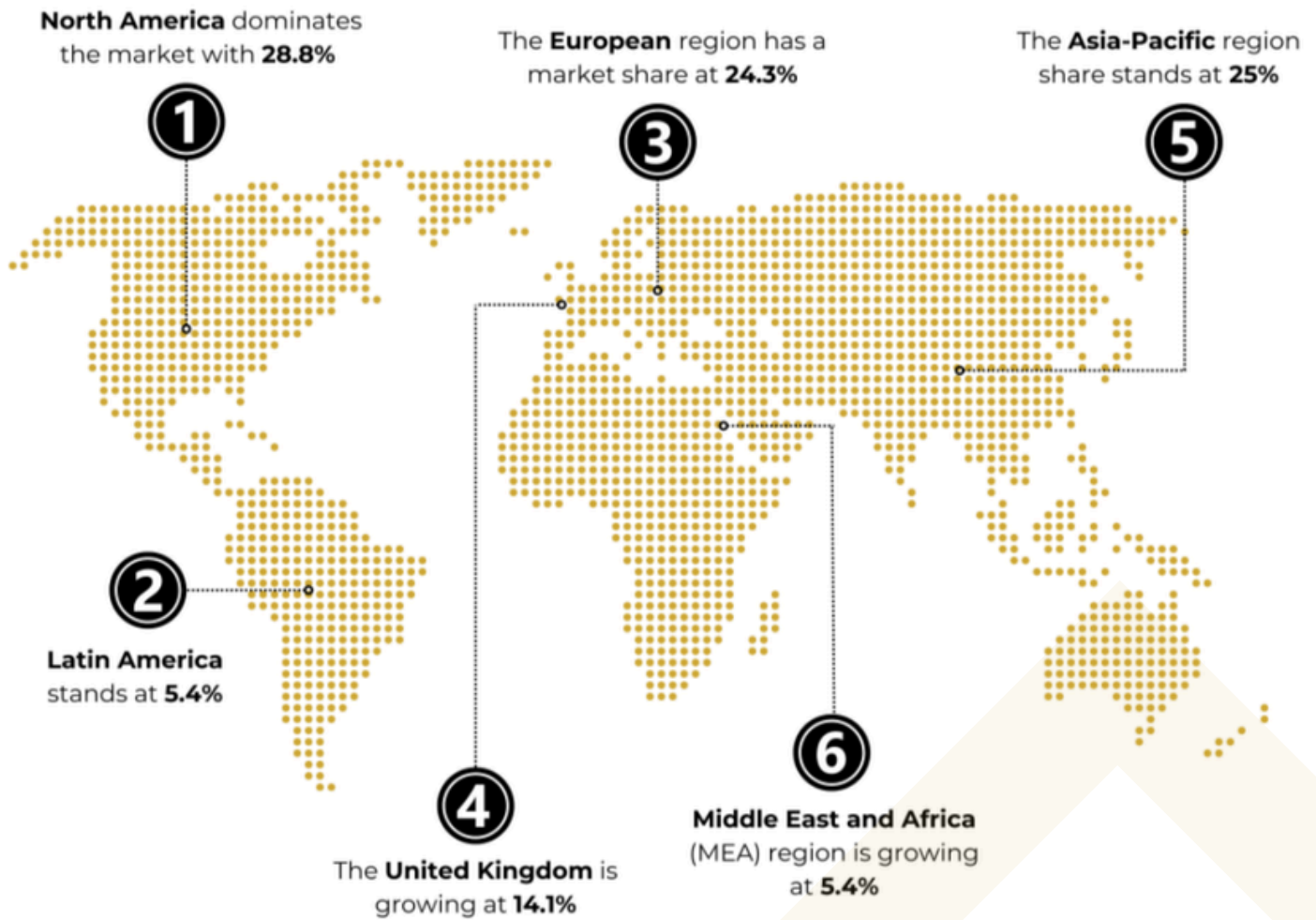


Figure 1: Market Share of AI from a Regional Perspective

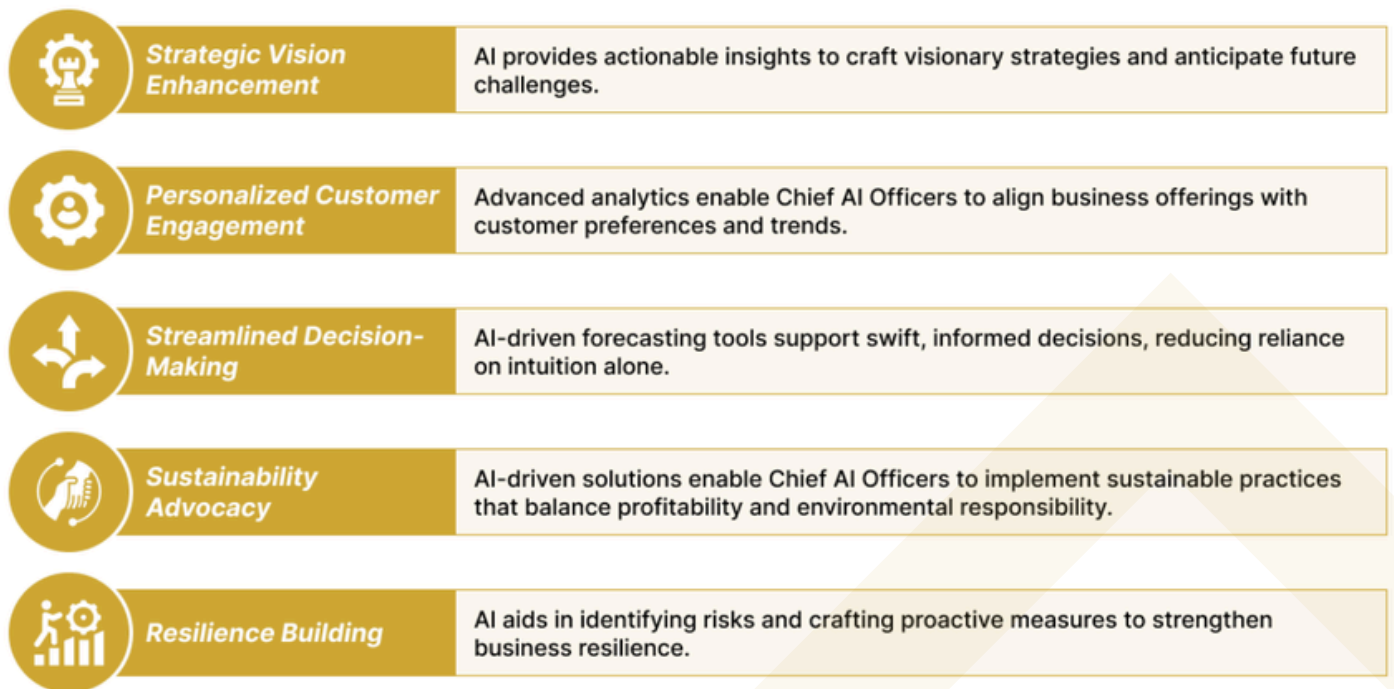


Figure 2: Exploring How AI Transform Roles and Responsibilities of Chief AI Officers

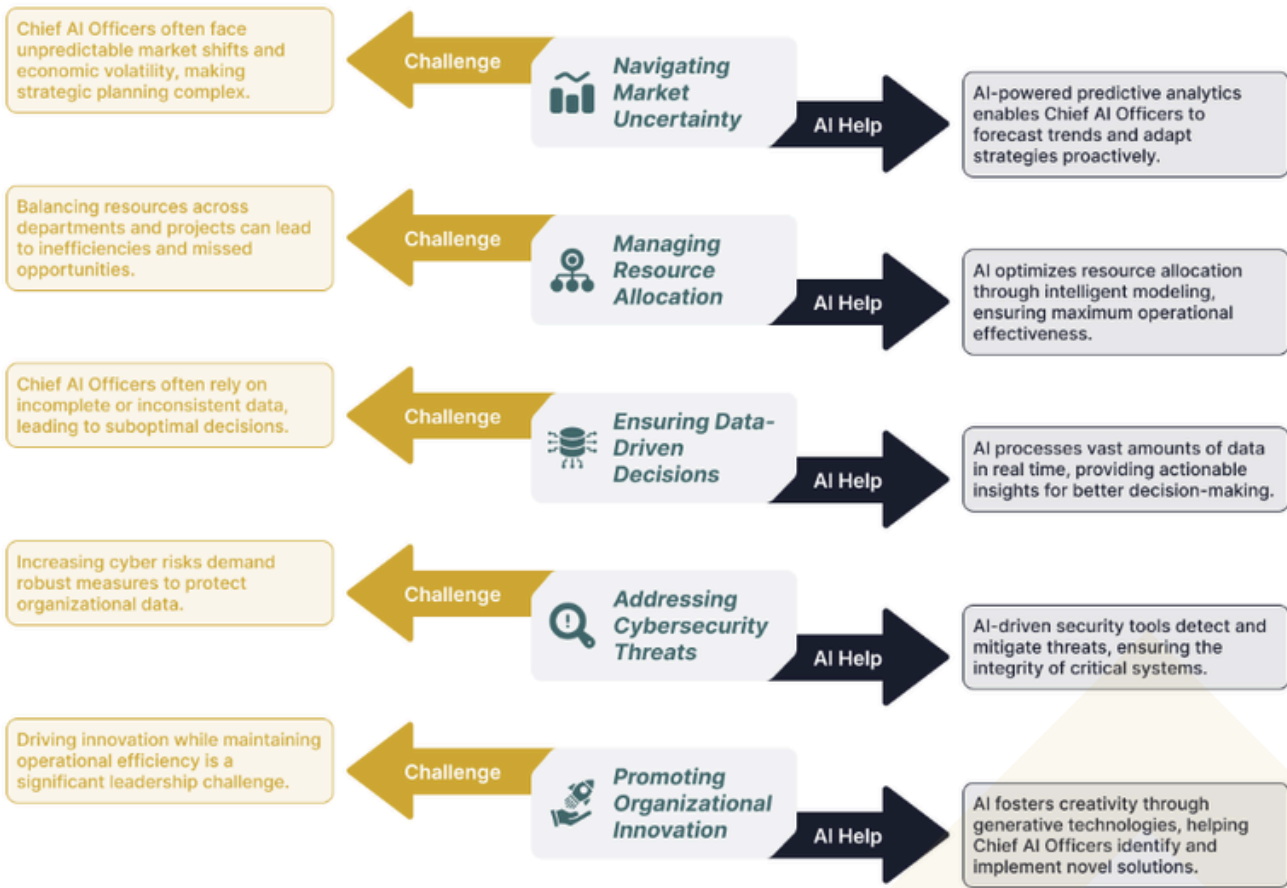


Figure 3: AI Addressing Current Challenges for Chief AI Officers

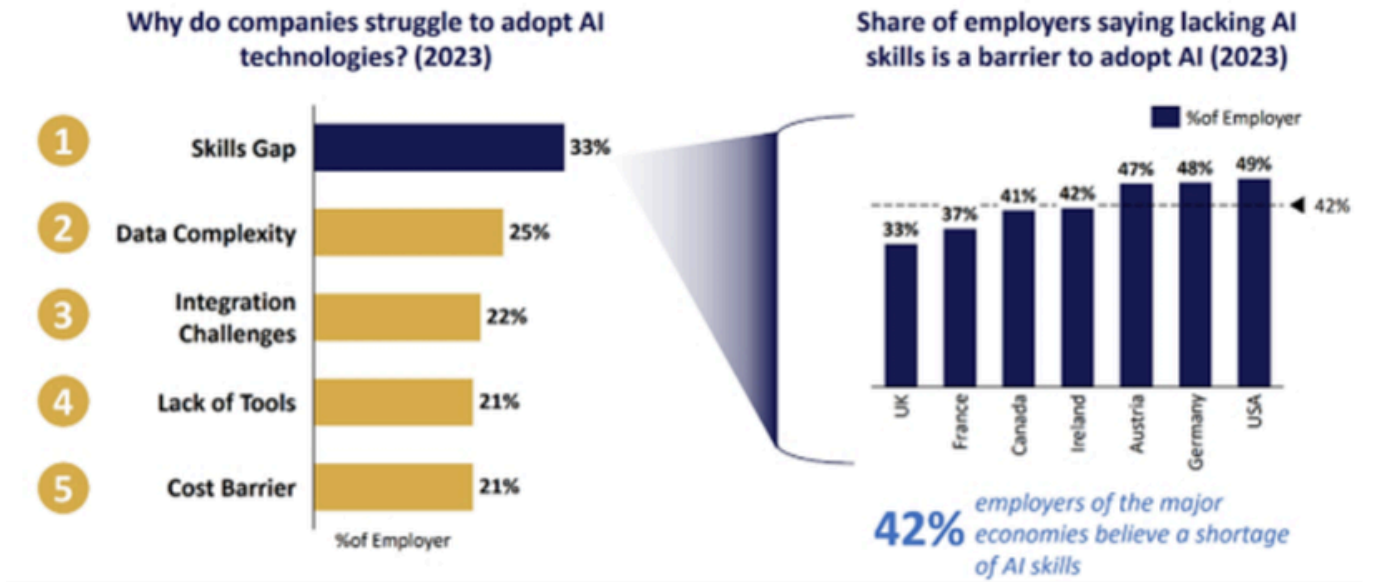


Figure 6: Factors determining the lack of adopting AI Technologies
